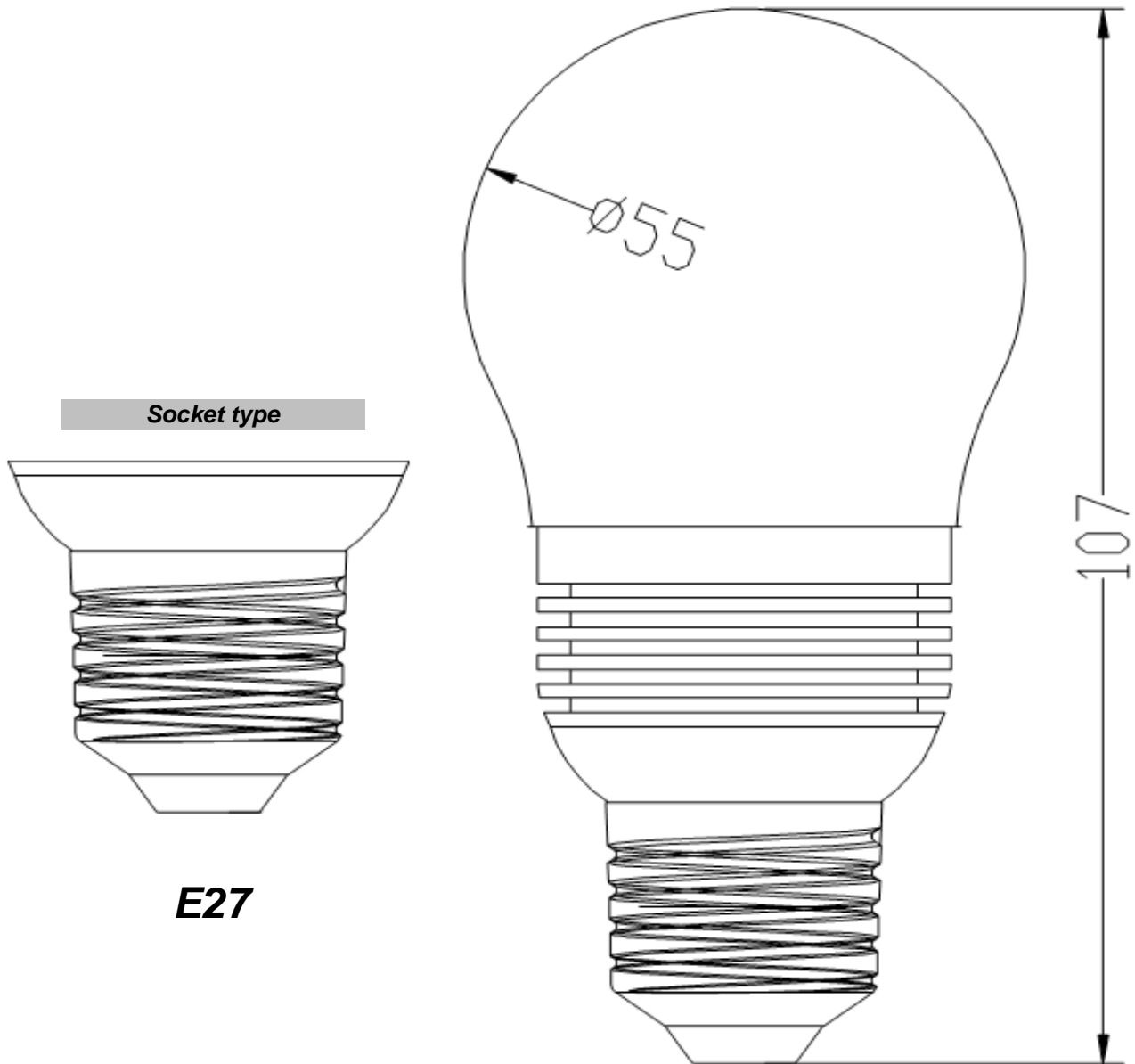

**Technical Drawing (mm)**



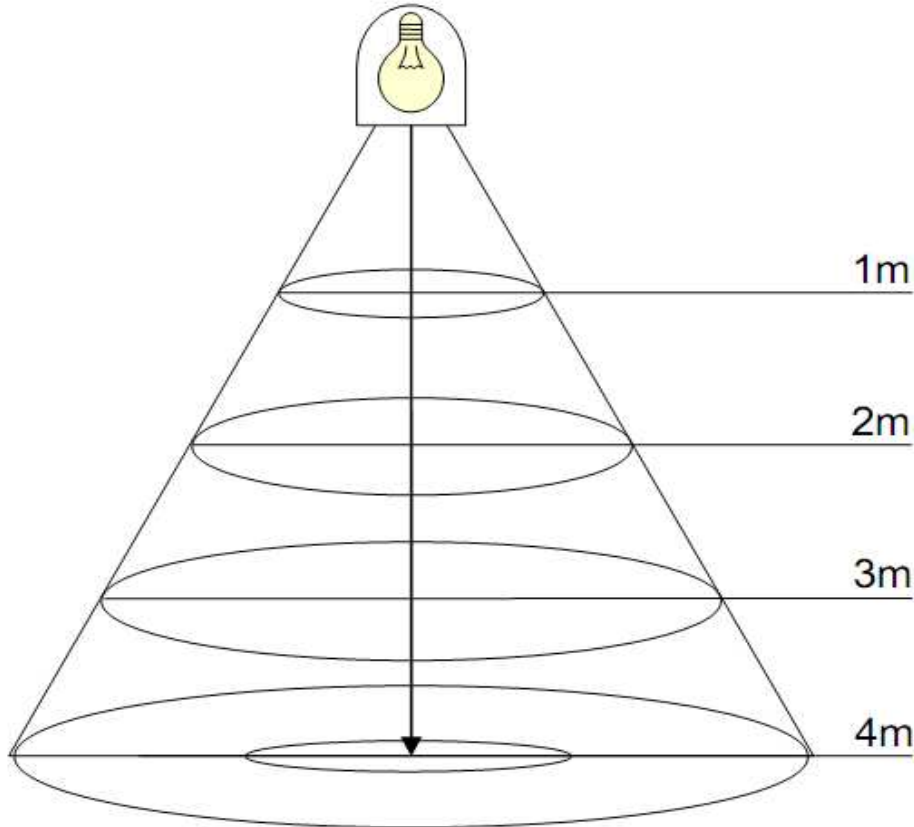

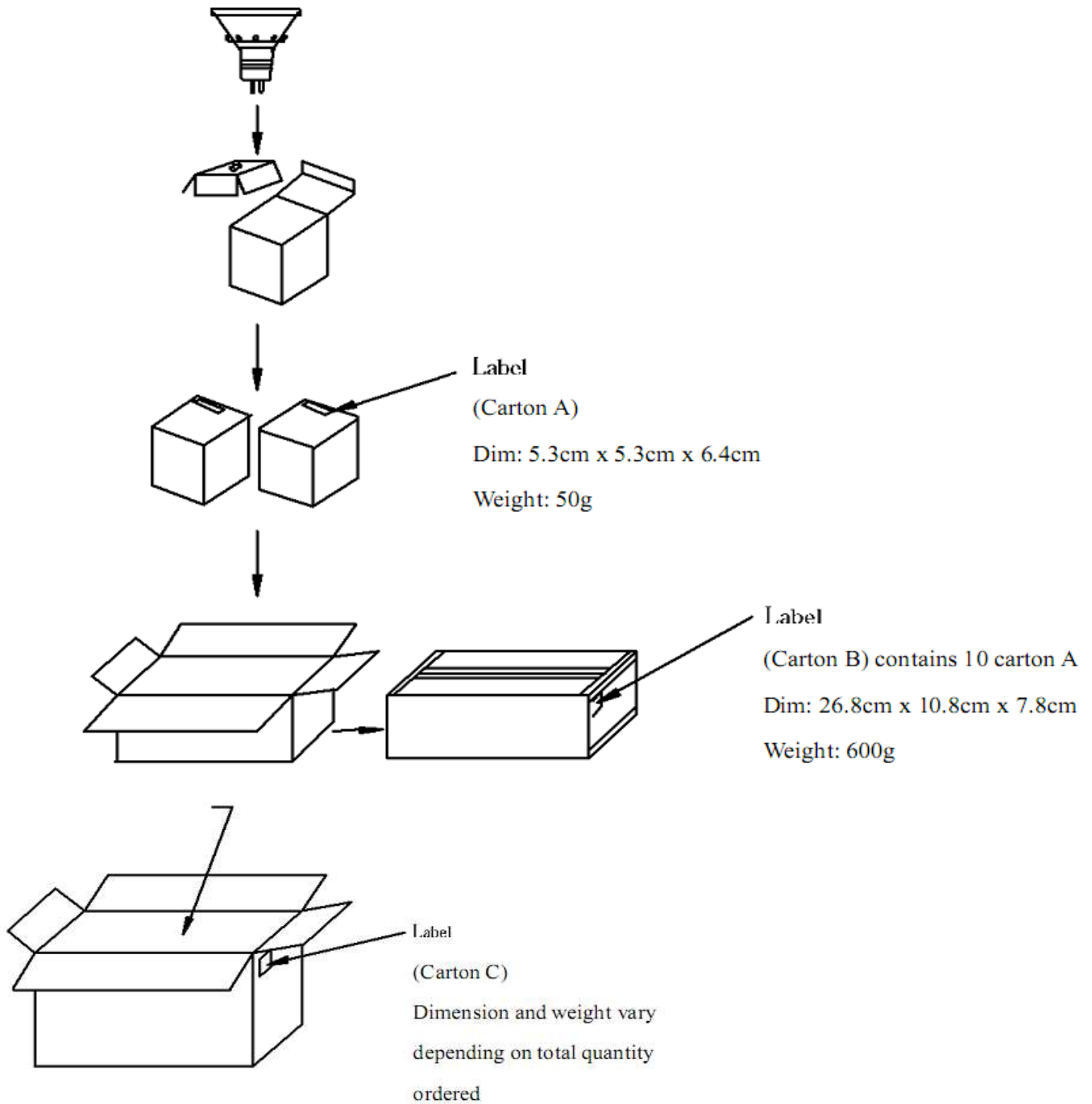
